

DUQUESNE LIGHT COMPANY AUTOPAY ENROLLMENT
SWEEPSTAKES RULES & REGULATIONS

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1.SWEEPSTAKES PERIOD: The Duquesne Light Company ("DLC") Autopay Enrollment Sweepstakes (the "Sweepstakes") starts on September 1, 2026, at 12:00am Eastern Standard Time ("ET") and closes September 30, 2026 at 11:59pm ET ("Sweepstakes Period"). The Sweepstakes is sponsored by DLC, located at 100 S Commons, Suite 118, Pittsburgh, PA 15212.

2.ELIGIBILITY: This Sweepstakes is open only to customers of DLC who are legal residents of the DLC Service Territory with an active electricity account during the Sweepstakes Period (collectively, referred to as "Eligible Customers" or "Entrants"). All Entrants must be eighteen (18) years of age or older at the time of entry into the Sweepstakes. Entrants must be the named account holder of the billing account and be enrolled in Autopay during the Sweepstakes Period and on the Drawing Date, as defined herein, in order to be eligible. The Entrant's customer account must be current in payment and otherwise in good standing to be eligible. Employees, agents, and representatives of DLC and its subsidiaries and affiliates are not eligible to win, nor are the parents, siblings and children of any such employee, agent, or representative or any person with whom such employee, agent, or representative is domiciled.

3.PRIZES: Two (2) potential winners (each, a "Winner" and collectively, "Winners") will be randomly drawn after the conclusion of the Sweepstakes Period to each receive one (1) \$500 cash prize in the form of an emailed e-gift card issued by Tango Card Inc. (the "Prizes"). Total Approximate Retail Value of all Prizes: \$1,000. DLC reserves the right to extend the Sweepstakes Period and to award additional Prizes of the same or differing amounts, in its discretion. DLC reserves the right to extend any Quarterly Sweepstakes Period or the Sweepstakes Period and to award additional Prizes of the same or differing amounts, in its discretion. DLC provides no warranty for the Prizes, and specifically disclaims any liability concerning the quality, safety, use or installation of the Prizes.

4.HOW TO ENTER:

(a) Online. The Sweepstakes is offered electronically via the Internet. Eligible Customers (as defined above) who (1) have an active electricity account with DLC, (2) participated in the Sweepstakes by enrolling in Autopay during the Sweepstakes Period and (3) remain enrolled on the Drawing Date are automatically entered in the Sweepstakes drawing. Also, Eligible Customers who (1) have an active electricity account with DLC, (2) were previously enrolled in Autopay and (3) remain enrolled during the Sweepstakes Period and on the Drawing Date will be automatically entered in the Sweepstakes. Each Entrant may only submit one entry into the Sweepstakes, whether by the online method or the mail-in method described below.

(b) Mail-in Method. As an alternative to the online method, Entrants may enter by legibly printing the Entrant's name, street address, city, state, postal code, telephone number, complete email address and electricity account number and the words "AUTOPAY SWEEPSTAKES" on a 3 x 5 inch (or 7.5 cm x 12.5cm) piece of paper and mailing it to: Duquesne Light Company, 100 S. Commons St, Suite 118 CUS-L1, Pittsburgh, PA 15212, Attn: Autopay Sweepstakes. All entries become the exclusive property of DLC and will not be acknowledged or returned. Mail-in entries that do not include the electricity account number will not be valid. The entry must be received by DLC during the Sweepstakes Period to be eligible.

for the Drawing. An Entrant who enters by the mail-in method acknowledges and agrees that submission of a mail-in entry constitutes consent for DLC, in its sole discretion, to contact the Entrant by phone or email regarding enrollment in autopay.

5.SWEEPSTAKES DRAWING: Drawings of the Prizes will be held in Pittsburgh, Pennsylvania no later than 30 days after the conclusion of the Sweepstakes Period or on another date determined by DLC in its sole discretion (the "Drawing Date"). Winners will be determined by random drawing from all eligible entries received. The odds of winning depend on the number of eligible entries received. The odds of an entry winning any Prize will be the same, whether the entry was automatically generated (for online participants) or by alternate means of entry. All decisions of DLC regarding the Prize drawing and any and all other aspects of the Sweepstakes shall be final, binding and non-appealable.

6.PRIZE AWARDING: Winners will be notified by email, telephone, U.S. mail or other reasonable means within sixty (60) days of the Drawing Date. Prizes will be awarded only on verification that all Sweepstakes requirements have been met by the Winners in accordance with this agreement. Each Prize must be accepted as awarded and no substitution, transfer, conversion or assignment of Prizes will be allowed, unless at the discretion of DLC which may substitute a Prize of comparable or greater value. If a Winner does not respond within three (3) business days of the initial notification, DLC will contact the Winner a second time with a final notification. Each Winner will have two (2) business days from this second notification to accept the Prize. DLC is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify a Winner. In order to be declared an official Winner, the Winners will be required to digitally consent to the Sweepstakes Rules and Winner Declaration Conditions ("Declaration and Release"). If a Winner cannot be contacted or fails to consent to the Declaration and Release within seven (7) business days after notification thereof, DLC reserves the right to void that entry and select another eligible Entrant for that Prize in a random drawing from among all remaining eligible entries. By digitally consenting to the Declaration and Release, the Winner (i) confirms compliance with these Sweepstakes Rules and Regulations, (ii) releases and forever discharges DLC, its affiliates and subsidiaries from all claims, demands, damages, actions, and causes of action arising or to arise by reason of the acceptance or use of the Prize, and (iii) grants to DLC (and its licensees and partners) a non-exclusive, worldwide, royalty-free, perpetual license to edit, publish, promote, republish at any time in the future, and otherwise use Winner's name, likeness, biographical information, and any other information or materials provided by the Winner, in any and all media now known or hereinafter devised, without territorial restriction (except where prohibited by law), for possible editorial, publicity, promotional or advertising purposes, without further permission, notice or compensation (except where prohibited by law), including, without limitation, publication by DLC of video and photographic images of the presentation of Prizes to the Winners.

DLC agrees to take such action in a fair and appropriate manner.

11.APPLICABLE LAWS: This Sweepstakes is subject to all applicable federal, state and county laws. Void where prohibited or restricted by law.
